



Lakota Family YMCA Membership Policies and Agreements

- I authorize the Lakota Family YMCA to draft my billing method credit card or debit card account monthly that I have provided on the date I join.
 - Monthly memberships are subject to a 12-month contract that I signed and understood when I filled out my membership application at Lakota Family YMCA.
 - I understand that monthly dues will be electronically drafted on the 1st of each month and my first payment is a pro-rated rate for that month.
- Should any member debt not be honored by the members credit card company or bank for any reason, the member is still responsible for the payment plus a service charge applied by the Lakota Family YMCA. This is in addition to any service fee the member's cred card company or bank may charge. The memberships is subject to termination if debt is not paid.
- The Lakota Family YMCA does not refund any membership fees due to non-usage of facilities or programs.
- A joining fee is required to rejoin the Lakota Family YMCA following more than sixty (60) days of inactivity.
- A seven (7) business day termination notification prior to the first of the month draft date is required for cancellation. Notice must be submitted in writing via form available at the Front Desk, by email to the Membership Director or Billing Coordinator.
 - Cancellations will be up for review and are not guaranteed if within term.
- If termination notification is submitted in writing within thirty (30) days of the initial join date, the Lakota Family YMCA will refund the initial payment minus a \$50 administration fee.
 - If initial payment is less than \$50, no fees will be returned.
- Membership cards must be scanned at the front desk to access the facility.
- Membership cards remain the property of the Lakota Family YMCA and must be surrendered upon demand.
- Guest are welcome at the Lakota Family YMCA, space permitting. Limit: 2 guests per active member. Three (3) visits per guest per month. Guest must always be accompanied by a member, and have a picture ID.

- Parents/Guardians are responsible for the safety and supervision of their children at all times. Children under the age of 10 years may not be left unattended in the facility and children under the age of 12 years that have not attained a GREEN swim band may not utilize the pool without a parent/guardian.
- Unsupervised workout using cardiovascular equipment or free-weights is not permitted prior to age 16 years. No one under the age of 12 is allowed in the Fitness Center. Ages 12-15 can work out in the fitness center with limitations after there is a waiver signed by the legal guardian, a medical clearance form on file and completion of 2 classes of our Youth Fitness Training Program with our Certified Personal Trainer.
 - Members who are 15 years old can use the free weights, cardio and selectorized equipment without an adult present upon completion of the Youth Fitness Training Program.
 - Members who are ages 12-14 can use cardio equipment only under the supervision of their legal guardian after the two class of the Youth Fitness Training Program are completed.
- The Lakota Family YMCA is founded on Christian principles-respect, responsibility, honesty, caring – and prohibits inappropriate behavior and conduct. Behaviors by members are patrons deemed threatening or harmful to the wellbeing of the public while at the Lakota Family YMCA functions will initiate a staff review process which may result in the termination of membership or services.
- I understand the Lakota Family YMCA is not responsible for personal or vehicular property loss, damage, or stolen while members and/or program participants are using the Lakota Family YMCA facilities, on the premises, or involved in the Lakota Family YMCA programs.
- Lakota Family YMCA and all areas are tobacco, drug and alcohol free. This also includes and is not limited to paraphernalia such as e-cigarettes.
- Lakota Family YMCA reserves the right to review any membership application and deny membership to any member at the discretion of Y Management.
- I further understand that Lakota Family YMC management has the authority to amend policies and procedures at any time to ensure the delivery of the highest possible services to the general membership.
- The Lakota Family YMCA may, at our discretion, adjust the monthly rate applicable to the member's membership category. The member will receive a four(4)-week notice prior to any such change.
- I authorize the use of any photographic or video image of the member(s), named herein, during any program or activity, for use in any Lakota Family YMCA publication or outreach.

- The member acknowledges that it is the policy of the Lakota Family YMCA to deny membership, program participation or visits to any individual convicted of a crime for which registration as a sex offender is required and that the Lakota Family YMCA will regularly monitor its database for criminal history.
- Cell phone/Videotaping: Due to the advances in video equipment and telephone video technology, and for the safety and security of our members and guests, any and all video equipment may not be used in locker rooms, dressing areas, shower areas, restrooms, lobby, common areas and other areas generally deemed to be private within the Lakota Family YMCA facility and property. Members and participants must refrain from capturing videos that include other members in the background for use on personal social media. The Lakota Family YMCA requests that cell phone usage be reserved for designated cell phone areas only.
- I understand that Lakota Family YMCA activities have inherent risks and in consideration for membership at the Lakota Family YMCA and participation in programs I hereby assume all risks and hazards incident to my participation in all activities, due to negligence of the Lakota Family YMCA or otherwise while in, about, or upon the premises of the Lakota Family YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the Lakota Family YMCA, including volunteer service. I further waive, release, absolve, indemnify, and agree to hold harmless the Lakota Family YMCA, the organizers, volunteers, supervisors, officers, directors, participants, coaches, referees, as well as persons or parents transporting participants to and from activities from any claims or injury sustained during my use of the Lakota Family YMCA property or participation in programs. I expressly assume all dangers, risks, and hazards to me and all minors in my care.
